2. The interested Tenderers should fill in their bid amount in the relevant column in the tender form The tender form duly completed & sealed in double cover along with the signed Terms& conditions and Bank Daft of Rs 10000/- towards Earnest Money Deposit, payable in favour of the Secretary, National Institute of Open Schooling A-24/25 Institutional Area Sector -62 NOIDA-201309 and drawn on any Nationalized Bank, should be deposited in the Tender Box well before the last date for submission of the tender i.e. 13/09/2010 upto latest by 2.00P.M.
