

On the recommendations of the 20th Meeting of the Evaluation Committee held on 12th June, 2015, 17th Meeting of the Academic Council held on 23rd July, 2015 and in pursuance of the approval by the 69th Meeting of the Executive Board of NIOS held on 11th September, 2015, the examination fees for Public Examination, On Demand Examinations (for Secondary and Senior Secondary courses) and examination fees for Vocational course (including Theory and Practical) have been revised. The details of revised fees are given as under:

1.	Public Examination (For Secondary & Senior Secondary Courses)	
(i)	Examination fees per subject	Rs.250/- per subject
(ii)	Additional fees for subjects having practical components	Rs.120/- per practical subject
(iii)	Late fees (For First 10 days)	Rs.100/- per subject
(iv)	Consolidated late fee to be received at Regional Centres only (for next 10 days after late fee)	Rs.1,500/- consolidated
2.	On Demand Examination (For Secondary & Senior Secondary Courses)	
(i)	Examination fees per subject	Rs. 500/- per subject
(ii)	Additional fees for subjects having practical components	Rs. 200/- per practical subject
3.	Examination Fees for Vocational Courses (including theory, practical & internal examination)	Rs. 300/- per subject/ module
