## NOTIFICATION - 72/2014

Consequent upon the approval of the Finance Committee of NIOS in its 53<sup>rd</sup> meeting held on 11.02.2014, it is notified that NIOS has revised the fee for admission in Academic programmes i.e. at Secondary(X) and Senior Secondary(XII) as follow:

1. Registration fee has been enhanced by ₹ 100/- i.e. ₹ 350/- from ₹ 250/-.
2. Subject fee has been enhanced for each additional subject by ₹ 50/- per subject for both Secondary and Sr. Secondary making the subject fee ₹ 200/- from ₹ 150/- for Secondary and ₹ 230/- from ₹ 180/- for Senior Secondary.

The details of the revised fee structure for both Secondary (X) and Senior Secondary (XII) will be as follows:-


