**Subject : Extension of Receipt of Accreditation fee from AIs/AVIs/AAs - regarding.**

Sir/Madam,


This is in continuation of Notification bearing no. 235 dated 1<sup>st</sup> October 2015 and subsequent letter No. F-23-5-7/2015/NIOS/SSS/Accr./5650-5069 dated 29<sup>th</sup> October 2015, on the subject stated above, it is once again reiterated that AIs/AVIs/AAs which have completed five years of accreditation with NIOS have to **deposit fee of Rs. 15,000/- for extension of accreditation** with NIOS. The last date for receipt of the revised accreditation fee was 30<sup>th</sup> November 2015, which has now been further **extended up to 20<sup>th</sup> December 2015.**

It has to be ensured that the fee for extension of accreditation is received within the stipulated time limit and the same intimated to NIOS Headquarters. It has also come to the notice of the SSS Department that many of the AIs/AVIs/AAs (Independent schools) are non-functional, the details of the same are also required to be sent to the Headquarters and appropriate action be taken for dis-accreditation of such of AIs/AVIs/AAs (independent schools).

In the event of non-compliance for payment of the fee for extension of accreditation, the admission of the concerned AIs/AVIs/AAs **would be stopped by the SSS Department.** The Regional Directors are directed to inform all the AIs/AVIs/AAs and also upload in the concerned Regional Centre's website.

This may be treated as **MOST URGENT.**
