Instances have come to the notice of the authorities whereby learners are being cheated by overcharging illegitimate fees through unauthorized Agencies/Coaching Institutes. Regional Centres need to share with common people and inform stakeholders that NIOS has no link with such institutes. It must be brought to the notice of the learners/parents and general public at large that NIOS has neither engaged any agency nor any coaching institution for the purpose of Admission/Accreditation etc. NIOS will also not be responsible for any excess payment towards Admission, Examination or fee for any other purpose to any of the unauthorized Agents/Agencies. Learners may be advised to submit the Admission/Examination fee either through the Online process through NIOS web portal www.nios.ac.in or through the Regional Centre/Accredited Institution (AI), Accredited Vocational Institution (AVI) of NIOS only, for timely credit of fee.

Instances have also come to notice that some of the Coaching Institutes unauthorizely giving advertisement in local Newspaper using NIOS Logo, whereby alluring NIOS learners to qualify Secondary and Sr. Secondary Examination with guarantee. It is submitted NIOS has not authorized such of the coaching institutes for unwarranted activities thus, damaging/ credibility of NIOS among the public at large.

In order to curb such type of illegal/ unauthorized activities by Coaching Centres, which are noticed by the Regional Centre concerned, the details of the unauthorized Coaching institutes which are giving advertisement promising to pass Secondary and Sr. Secondary, NIOS Examination with guarantee and misleading the learners be forwarded to NIOS Headquarters so as to facilitate to take further appropriate action.
