

विषय: Memorandum of Understanding of Kendriya Vidyalaya Sangathan with National Institute of Open Schooling for establishment of Study Centres and Examination Centres of NIOS - regarding.

महोदय / महोदया,

A Memorandum of Understanding (MoU) has been signed on 25<sup>th</sup> January, 2016 between Kendriya Vidyalaya Sangathan (KVS) and National Institute of Open Schooling (NIOS) whereby single shift KVs with adequate infrastructure will work as NIOS Study Centres and for conduct of On Demand Examination (ODE) of NIOS Courses. Both the institutions will work together towards the national goal of providing quality education for all. This would also help in improvement of quality of school education - formal system (being imparted in Kendriya Vidyalayas) as well as Open & Distance Education (being imparted by NIOS). As per the MoU, the Role of KVS will be to:

1. Organize the NIOS On Demand Examination at single shift Kendriya Vidyalayas that are also having the facility of Science Laboratory at Secondary and / or at Senior Secondary Level (Physics, Chemistry, Biology etc.)
2. Provide one room to be the 'On Demand Examination' Centre of NIOS at each school, which will have capacity to accommodate at least 20 learners to appear for Examination at a time.
3. Provide the following equipments and peripherals for the On Demand Examination at the Centre:
  - One Computer with required software
  - One Laser Printer
  - One Scanner
  - One Photocopier Machine
  - 2 mbps internet connectivity with one static IP
4. Designate all Principals of the Kendriya Vidyalayas as the Centre Superintendent and depute two teachers for invigilation during the time of examination. In case the Principal is not available due to Tour or leave or other important official assignment, he/she may depute the Vice Principal or the Senior Most Teacher to act as the Centre Superintendent.
5. Ensure proper maintenance of the CCTV equipments with IP based camera for remote monitoring provided by NIOS.
6. Take the support of NIOS for the capacity building of the teachers for undertaking activities related to NIOS.

In view of the above, you are requested to direct the Principal of Kendriya Vidyalayas under your jurisdiction to co-operate accordingly with the NIOS officials for establishment of NIOS Study Centres and On Demand Examination Centres.
