- 3) The Electrical wiring shall be fire retardant wires of Polycab/Finolex or any other ISI make and LED shall be of Samsung make modules.
- 4) The defect liability period for this work shall be of one year. During this period, if any defects occur will be rectified by the tenderer free of cost. No amount shall be paid by NIOS for rectification of defects.
- 5) The work shall have to be carried out in neat and tidy manner to the entire satisfaction of NIOS and all care shall have to be taken to ensure that no part of the building gets damaged during execution of work.
