In continuation to the Notification No. 21/2014 dt. 27.11.2014 with regard to conduct of Practical Examinations of NIOS Secondary and Senior Secondary Courses at the Accreditated Institutions (AIs.) by linking Practical Personal Contact Programme (PCP) Classes have been implemented from admission cycle 16th March 2015 onwards and the first Public Examination will be held in March-May 2016.

A specimen copy of Award Slip for the conduct of formative and summative Assessment for practicals is enclosed herewith. The concerned AIs are required to keep a record of the details of marks awarded on the Award Slip as and when required for its official purpose. The concerned AI need to complete the final award of a relevant public examination on the pre-printed Award Slip to be forwarded by the concerned Regional Centres before the Examination to be conducted.

All Regional Directors are hereby directed to circulate the specimen copy of the Award Slip to all the AIs for conduct the Practical Examinations as per the procedure laid down in the Guidelines for the conduct of Practical Examinations for March-May 2016 Examinations onwards as stated in the Notification 21/2014 dated 27th November, 2014. The marks awarded for the formative and summative Assessment be recorded separately in the specified column of the Award Slip and the same has to be maintained by the AIs for official record in the AIs.
