(Offline) J&K 2017-19 batch for second year subjects only shall be opened as per the following schedule **only for the learners who could not pass October-November, 2024 examination or have passed this examination and wish to improve their marks.**

1.	For all eligible learners @ Rs.400/- per subject/Module (Inclusive of theory, practical and internal assessment if any)	24 <sup>th</sup> March, 2025 to 02 <sup>nd</sup> April, 2025 (without late fee)
2.	With late fee of Rs. 150/- per subject in addition to the fee given in Sl. No.1 above	03 <sup>rd</sup> April, 2025 to 07 <sup>th</sup> April 2025 (with late fee)
3.	With consolidated late fee of Rs. 1600/- per learner in addition to the fee given in Sl. No. 1 above	08 <sup>th</sup> April, 2025 to 12 <sup>th</sup> April 2025 (with consolidated late fee)

**No offline forms or examination fee will be accepted.**
