NOTIFICATION - 265/2016

As per the existing Guidelines and Standard Operating Procedures for implementation of Open Basic Education Programme 2015 (Revised)(Bye-Laws governing examinations and certification), clause 8.2.2, it is mandatory for the Accredited Agency (AA) for Open Basic Education to get the translated version of English, Hindi and any other regional language to be attested by the First Class Magistrate. Similarly, the Accredited Institutions (AIs) and Accredited Vocational Institutions (AVIs) also need to get the translated version of English, Hindi and any other regional language to be attested by the First Class Magistrate.

It has been noticed that the AIs, AVIs and AAs are finding it difficult to get the affidavit to be submitted by the Principal/Head of the Institution while applying for the accreditation in NIOS to be attested from the first class Magistrate. In order to overcome the inconvenience to AIs, AVIs and AAs, it has now been decided by the Competent Authority that, the AIs, AVIs and AAs be allowed to submit the affidavit duly attested by the Notary Public. In case, the notary attested affidavit turn out to be fabricated/forged or the statement given in the affidavit is found to be false, the AI/AVI/AA will be proceeded against in accordance with the law. The affidavit required to be submitted by the Principal/Head of the applicant school for accreditation from NIOS on a non-judicial stamp paper of Rs. 100 to be sworn by the Notary Public for the purpose. The prescribed format (Annexure) for the purpose is attached.
