- (a) that I am a citizen of India;
- (b) that I may, or likely to, engage outside India in activities prejudicial to the sovereignty and integrity of India;
- (c) that my departure from India may, or is likely to be detrimental to the security of India;
- (d) that my presence outside India may, or likely to prejudice the friendly relations of India with any foreign country;
- (e) that I have, at any time during the period of five years immediately preceding the date of my application, been convicted by a court in India for any offence involving moral turpitude and sentenced in respect thereof to imprisonment for not less than two years;
- (f) that proceedings in respect of an offence alleged to have been committed by me are pending before a criminal court in India;
- (g) that a warrant or summons for the appearance, or a warrant for the arrest, of the applicant has been issued by a Court under any law for the time being in force or that an order prohibiting my departure from India has been made by any such court;
- (h) that I have been repatriated and have not reimbursed the expenditure incurred in connection with such repatriation;
- (i) that in the opinion of the Central Government, the issue of a passport or travel document will not be in the public interest
