



S.K.Prasad, System Analyst / Programmer (SA/P) by 7th day of every month, so that proper monitoring can be done regularly. In case no information has been asked for, then 'NIL' record must be sent.



• Sh. S.K.Prasad, SA/P have been assigned the work of maintaining the required information under the Act and otherwise also, in print and electronic form, at all required places. He will responsible for ensuring that all the required information, under the Act, and also otherwise, is made available on the NIOS website and is updated as and when required, so that public can access it at any time. Shri Rajesh Gautam, Section Officer (Maintenance Branch) will responsible for sending the Monthly, Quarterly and Annual Return under Section 25 of RTI Act, to Central Information Commission (CIC) as well as Ministry of Human Resource Development (MHRD).
